

## **ORDINANCE 11-A-16**

### **AN ORDINANCE FIXING THE SALARIES OF VILLAGE PRESIDENT, VILLAGE CLERK, VILLAGE TREASURER AND BOARD OF TRUSTEES OF ROYAL, ILLINOIS:**

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF THE VILLAGE TRUSTEES OF THE VILLAGE OF ROYAL, ILLINOIS:

That the ordinance fixing the salaries of the President, Clerk, Treasurer and the Board of Trustees of The Village of Royal, Illinois, be amended to read as follows:

**Section I.** That for the elected position of Village President of the Village of Royal, Illinois, the Village President shall receive annual compensation of six hundred dollars (\$600.00), payable semiannually, at the March meeting and the September meeting.

**Section II.** That for the appointed position of Village Clerk of the Village of Royal, Illinois, the Village Clerk shall receive annual compensation of six hundred dollars (\$600.00), payable semiannually, at the March meeting and the September meeting.

**Section III.** That for the appointed position of Village Treasurer of the Village of Royal, Illinois, the Village Treasurer shall receive annual compensation of eight hundred dollars (\$800.00), payable semiannually, at the March meeting and the September meeting.

**Section IV.** That for the each elected position of Village Trustee of the Village of Royal, Illinois, the Village Trustee shall receive monthly compensation of forty dollars (\$40.00), per meeting actually attended, payable semiannually, at the March meeting and the September meeting.

**Section V.** That all Board member, whether elected or appointed, shall receive additional compensation of thirty dollars

(\$30), per special meeting actually attended, payable semiannually, at the March meeting and the September meeting.

**Section VI.** That all board members whether elected or appointed, are expected to attend seventy-five percent (75%) of all regularly scheduled meetings.

**Section VII.** That all resolutions or ordinances conflicting herewith be and the same are hereby repealed, and that this ordinance shall take effect forthwith upon its passage and approval.
