

TAX LEVY ORDINANCE

WHEREAS:, the BOARD OF TRUSTEES of the VILLAGE OF ROYAL, in County of Champaign and State of Illinois, did on the 4th day of June A.D. 2018, pass the annual appropriations bill for said Village for the fiscal year beginning on the 1st day of April A.D. 2018, the amount of which is ascertained to be the aggregate sum of, Eighty Seven Thousand Three Hundred Dollars, which said appropriation bill was duly posted on the 5th day of June A.D. 2018. Now, therefore,

AN ORDINANCE FOR THE LEVY AND ASSESMENT OF TAXES FOR THE CURRENT FISCAL YEAR

BE IT ORDAINED by the BOARD OF TRUSTEES of the VILLAGE OF ROYAL Illinois:

Section 1. That there be and is hereby levied upon all the taxable property within the corporate limits of said VILLAGE OF ROYAL subject to taxation for the year A.D. 2018 the total sum of Four Thousand Eight Hundred Fifty Eight Dollars, for the following specific purposes mentioned in said appropriation bill and in the respective sums as follows, to-wit:
